### Caledonia declares quarterly dividend

**St Helier, April 3, 2023 –** Caledonia Mining Corporation Plc ("Caledonia" or the "Company" - <u>https://www.commodity-tv.com/ondemand/companies/profil/caledonia-mining-corporation-plc/</u>) is pleased to announce that the Board of Directors has declared a quarterly dividend of 14 United States cents (US\$0.14) on each of the Company's shares.

#### Commenting on the announcement, Mark Learmonth, Chief Executive Officer, said:

"The total dividend paid for 2022 was 56 cents per share, a 12% increase on the 50 cents per share in 2021. The quarterly dividend, which remains at 14 cents a share, continues to be an important part of the Company's strategy and we believe sets us apart from our peer group."
